## RE: IRREVOCABLE PAYMENT INSTRUCTION UNDER DEPOSITORY AGREEMENT DATED 20 MAY, 2011, BETWEEN THE FEDERAL GOVERNMENT OF NIGERIA AND J.P. MORGAN (THE "DEPOSITORY AGREEMENT")

We refer to the Depository Agreement between the Federal Government of Nigeria (FGN) and J.P. Morgan Chase, N.A., London branch, dated May 20<sup>th</sup>, 2011.

- 2. We also refer to our earlier letter Reference No. PSF/FMF/C-SH/273 dated 25<sup>th</sup> July, 2011 on irrevocable transfer of the sum of USD1,016,540,000.00 (One Billion Sixteen Million Five Hundred and Forty Thousand US Dollars Only) from the Escrow Accounts to the Accounts of Malabu Oil & Gas Ltd and that of Court Funds Office of England and Wales.
- 3. You are by this letter of instruction to cancel the transfer earlier given for the sum of \$801,540,000.00 (Eight Hundred and One Million, Five Hundred and Forty Thousand US. Dollars only) to Malabu Oil & Gas Account with Banque Misr Liba Sal, Belrut, Lebanon and transfer the same amount of USD801,540,000.00 (Eight Hundred and One Million Five Hundred and Forty Thousand US Dollars Only) from the Depository Account to the Accounts of Malabu Oil & Gas Ltd with the following details:
